1. In each sub-section, items/questions have each been assigned a maximum point value of ten (10) points. The total point value for each sub-section is reflected in the table below as the Maximum Raw Score Possible.
2. The agency has assigned Weighted Percentages to each sub-section according to its significance.

Data Security and Privacy	70	5	30
Totals	400	100.0%	600

*Sub-Section's Percentage Weight x Total Weighted Score = Maximum Weighted Score Possible for the sub-section.

The vendor's weighted score for each sub-section will be determined using the following formula:

$$(A/B) * C = D$$

A = Actual Raw Points received for sub-section in evaluation
 B = Maximum Raw Points possible for sub-section
 C = Maximum Weighted Score possible for sub-section
 D = Weighted Score received for sub-section

Vendor's weighted scores for sub-sections will be added to determine the Total Technical Score for the Proposal.

Vendor's whose *Technical Responses* that **do not** receive a minimum weighted score of 300 **shall not** be eligible to provide an oral presentation/demonstration and **shall not** move forward in the solicitation process and pricing **shall** remain sealed and **shall not** be scored.
