The vendor's weighted score for each sub-section will be determined using the following formula:

 $(A/B)^*C = D$ A = Actual Raw Points received for sub-section in evaluation

B = Maximum Raw Points possible for sub-section

C = Maximum Weighted Score possible for sub-section

D = Weighted Score received for sub-section

Vendor's weighted scores for sub-sections will be added to determine the Total Technical Score for the Proposal.

Vendor's whose *Technical Responses* that <u>do not</u> receive a minimum weighted score of 300 **shall not** be eligible to provide an oral presentation/demonstration and **shall not** move forward in the solicitation process and pricing **shall** remain sealed and **shall not** be scored.
