This 2-day professional learning experience is scheduled for Wednesday and Thursday, December 11-12, 2024 from 9:00 a.m. – 4:00 p.m., at the AALRC. Jayme Adelson-Goldstein, Educational Consultant with Lighthearted Learning, is the presenter.

In this training, instructors will explore and apply instructional techniques that incorporate intentional, direct instruction in listening strategies. By the end of the day, participants will be better equipped to help learners develop the skills necessary for authentic comprehension and communication. Instructors will also work with a variety of vocabulary learning strategies that help learners address their vocabulary needs and empower learners to fully express their ideas and understand others. The presenter is asking all attendees to complete a brief *pre-assessment* prior to the start of the training. Adult education funded participants will be reimbursed according to state travel guidelines (refer to Program Memo ADED 24-05 for full Travel Policy Guidelines). Local programs will be reimbursed mileage for one vehicle per four (4) participants and a second vehicle when more than four (4) attend an approved meeting, without advanced written permission from the Director of Adult Education. For 1-day trainings, participants must live or work (whichever is closer) 150 miles or more from meeting location in order to receive lodging reimbursement for the night before. Total maximum lodging reimbursement per night is \$110 plus tax. Participants must submit an original signed hotel receipt for reimbursement. **Registration is open!
